Household Hazardous Waste

Household Hazardous Wastes are things used in your home that should not be disposed of in either garbage or recycling containers.

What are they?

Accepted as HHW (no-cost drop-off)

They include:

- Aerosol cans (if not empty)
- Automotive fluids. **Do not mix.** (5 gal. or smaller, no more than 15 gal.)
- Batteries (auto, household, vaping)
- Fluorescent light bulbs, CFL lights (up to 10 per vehicle/day)
- Glues and adhesives
- Household cleaners
- Household paints (oil and latex) can be brought in for recycling under the [PaintCare.com](https://www.paintcare.com) program (5 gal. or smaller containers, up to 15 gal. per visit)
- Pesticides and garden chemicals
- Products with mercury (thermometers, thermostats, and lights with Hg printed on them)
- Pool and spa chemicals
- Propane tanks (various sizes, no commercial)
- Road flares
- Sharps (in puncture-proof container like a coffee can or detergent bottle – *No milk jugs or soda bottles*)
- Thinners and solvents

- ❌ Biological wastes
- ❌ Commercially generated hazardous wastes
- ❌ Computers & televisions
- ❌ Containers of HHW over 5 gallons
- ❌ Explosives – Call local law enforcement
- ❌ Radioactive waste
- ❌ Unused medications
