Bathroom Safety

Bathroom Safety

July 2018: hold discussion with Parks Department about locking and unlocking bathrooms

August- September 2018: identify volunteers to be key holders and begin key distribution from COPS to Neighborhoods and volunteers

August -October 2019: Monitor changes in calls for service to parks during hours which parks are closed

October 2018: COPS collect keys for winter

Spring 2019: redistribute keys

When

Built Environment

August 2018: 4 parks that will have the data tracked across time will be selected

October 2018: Research into blue lights in parks completed

December 2018: CPTEDs will be completed

January 2019: meet with parks to discuss potential grant opportunities for recommended improvements

Youth Activities

August-September 2018: Youth usage of parks survey completed

September 2018- March 2019: Identify organizations to provide desired activities to youth during peak usage hours

March- September 2019: Organizations start hosting and marketing activities in target parks

March- September 2019: Track the call for service data changes from previous year

Why

Parks should be safe friendly spaces for the entire community to enjoy and youth and families should feel supported and safe within their communities. This Initiative provides steps to increase the safety of the parks as well as increasing the accessibility of positive, intentionally selected activities for youth in District 1.

Challenges
