# District One Consolidated Meeting Notes (Quarter 1)

## March 15, 2017

# Northeast Community Center, 5:00 pm

Introductions/Meeting Goals: Brief overview of why we are here. We have already provided an orientation for Spokane Matters. Existing programs already are implemented that we can take advantage of how to better deal with problems across all three Districts, including District 1. This is a pilot program targeted at improving the process of delivering City services. There are numerous ways we can engage our community partners and increase collaboration and integration across the City and with community partners.

Tonight we will choose projects to move forward and have benchmarks to see progress on each project. This meeting is intended to give the group updates on pilot projects and measures, discuss next quarterly projects, implementation, and the appropriate participants for team work.

**Overview of Data/Mapping Tool:** This data has been a huge resource in identifying some of the internal pilot projects. It allows for real-time understanding and unique combinations of variables to be analyzed.

## Overview of existing Projects:

- 1. GIS Target Map for Abandoned Properties
  - This started as a goal to identify abandoned properties in district 1. City staff
    mapped relationships between troubled property, crime, and code enforcement
    services. The resulting map revealed abundant amount of potential targets; A 6
    block area was selected because of a focus on community assets and efforts to
    improve the citizen experience.
- 2. Junk Vehicles Pilot to move to proactive enforcement
  - Junk Vehicles in residential streets New way City crews can identify these junk vehicles and report to Code Enforcement and Parking Enforcement. To clear the roads of abandoned vehicles, the Streets department was brought in, which helps with the vehicle removal and also beautifies a neighborhood. Data was used in identifying this project and also utilizing existing programs and services to better serve around this issue.

- 3. Solid Waste Identify highest concentration of solid waste with the easiest and most efficient way to remove it.
  - Appliance removal in District 1 This was identified as the most productive way to remove garbage and waste. The appliance removal program was settled upon after working with the community stakeholders in District 1.

**Timeline:** Our goal is to have at least 30 days of notice before each meeting. Three dates have been offered and we are trying to schedule meetings that did not conflict with other meetings throughout District 1.

  - ☐ How can the City address these projects with the neighborhood more smoothly (better notification and outreach)
- Abandoned homes and crime
- Pedestrian safety issues around Cooper Elementary
- Child abuse and neglect rates are very high in Spokane (short term and long term goal to reduce these numbers)
- Increased affordable housing throughout District 1
- Increased pedestrian safety for children and families walking to parks and community pools
- Revitalize and increase safety around Mission Park
- Increased safety around Logan Elementary

#### Long Term:

- Neighborhood Safety (property crime, domestic violence)
- Road Construction/Development in the Yard don't have the funding for infrastructure
- Rochester Heights revitalizing a park to increase safety and create a design that deters crime

- Increase hours and staffing at the Northeast Precinct
- Housing stabilization and revitalization
