



Oversize/Overweight Vehicle Permit

Instructions & Information

Engineering requires per department policy that the applicant provide at least 2 working days before the permit is needed to allow time for processing.

Super and mega loads will require at least 4 working days to process.

Legal dimensions for commercial vehicles can be found in the Washington State Commercial Vehicle Guide. For a City of Spokane permit, the key dimensions and weights are as follows:

Width: 8'6" is the maximum legal width, anything wider requires a permit.

Height: 14' is the maximum legal height, anything taller requires a permit.

Overhangs: Anything over the following legal limits requires a permit.

- *Legal front overhang is 3' from the front of the normal bumper line.*
- *Legal rear overhang is 15' measured from the center of the last axle.*

Length: Legal lengths vary depending on the type of truck.

- *Single unit trucks such as dump trucks are legal up to 40' in overall length.*
- *Truck and trailer combinations are legal up to 75'.*
- *Semi tractors and trailers are measured by the trailer length only and are legal up to 53'. The maximum trailer length that they can be permitted for is 56'.*

Weight: Anything over the following weight limits requires a permit.

- *Gross Vehicle Weight: 105,500 lbs.*
- *Single Axle: 20,000 lbs.*
- *Tandem Axle: 34,000 lbs.*

Super Loads: A superload is any load which exceeds any of the following limits.

- *200,000 lbs. gross weight*
- *16 feet in height*
- *16 feet in width*
- *125 feet in trailer length*

Mega Loads: A Mega load is any loads which exceeds any of the following limits.

- *400,000 lbs. gross weight*
- *16 feet in height*
- *16 feet in width*
- *200 feet in trailer length*

Fees:

- Oversize - \$50 for thirty days.
- Overweight - \$75 for thirty days on a specified route.
- Superload - \$75 per single trip.

The City must honor State and County permits. Therefore, the City will only collect the permit fee if the route is wholly contained within the City limits. A fee may be assessed if part of the route is on State highways which are carried on City streets.

If the route is wholly on State highways, including State highways carried on City streets, you don't need a City permit.

If the route includes City streets but crosses the City limit and the applicant holds a State or a County permit, a City permit will be issued but a fee is not assessed.

All Permits are good for 30 days unless noted otherwise.

The City streets which carry State highways are:

- *Division/ Ruby Streets, (190 to the north City limit)*
- *Brown Street, (Division Street to 190)*
- *Newport Highway, (Division Street to Hawthorne Road)*
- *Trent Avenue, (Hamilton Street to Fancher Way)*
- *Francis Avenue, (Division Street to Nine Mile Road)*
- *Nine Mile Road, (Francis Avenue to the City limit)*
- *Sunset Highway, (Hwy 2, Sunset Blvd. to Deer Heights Road).*

Truck routes can be viewed on the City GIS website. Commercial vehicles are required to use truck routes as much as possible on their routes, although it is recognized that they may have to leave the truck route at some point to get to their destination. A proposed route would be considered to be confined to truck routes if it appears to be the most direct route to the destination using designated truck routes as much as is practical.
