*Projects highlighted in **RED** have notable changes this week. Construction is tentative and subject to change at any time.*

CONSTRUCTION PROJECTS

COCHRAN CONTROL FACILITY

- Work continues with no traffic impacts.

This project will construct a stormwater flow control vault.

This is a \$7.3 million project.

HIGH SYSTEM WATER TANK

- There are no impacts to the traveling public.

This project will construct a 2-million-gallon elevated steel and concrete water reservoir on the Hamblen Elementary property just south of Hamblen Park.

This is a \$9.8 million project.

SPOKANE INTERNATIONAL AIRPORT RESERVOIR

- No impacts to the traveling public are anticipated. Construction will be complete in 2024.

This project will construct a 3.6-million-gallon drinking water reservoir near the Spokane International Airport.

This is a \$13.3 million project funded with state and local funds.

THORPE RESERVOIR (THORPE & TRAINOR RD)

- Work continues with no traffic impacts.

This project construct five MG ground level steel water reservoir.

This is a \$5.1 million project.

WASHINGTON STEVENS CORRIDOR IMPROVEMENTS 2024

- Grind and overlay prep work on Stevens and Washington Streets continues between Spokane Falls Boulevard and 3rd Avenue. Stevens and Washington Streets have lane restrictions in place.

The Washington Stevens Corridor upgrades consist of three key projects aimed at enhancing the infrastructure and longevity of the roads and bridges in this area.

CITY OBSTRUCTIONS

- **The north curb lane of 2nd Avenue will be closed between Cedar and Walnut on 12/20/24 for Arc Electric & Lighting Corp. work.**
- Northbound Washington Street is reduced to one lane between Spokane Falls Boulevard and North River Drive from 12/10/24 to 12/20/24 for bridge work.
- The eastbound curb lane of Boone Avenue will be closed between Washington and Atlantic Street from 12/16/24 to 12/20/24 for Fatbeam to install fiber.
- The northbound curb lane of Crestline Street will be closed between Central and Nebraska Avenue from 11/25/24 to 12/20/24 for Fatbeam to install fiber.
- GeoEngineers Inc will be working in the follow areas from 11/18/24 to 12/20/24 to support exploratory drilling for design of US 395/I-90 interchange.
 - The north curb lane of 3rd Avenue closed between Cook and Nelson Street.
 - The north curb lane of 2nd Avenue between Crestline and Pittsburg Street.
 - The north curb lane of 3rd Avenue closed between Magnolia and Stone Street.
 - Lane closures on Altamont St between Pacific and 3rd Avenue.
- The south curb lane of 3rd Avenue will be closed between Division and Grant Street from 11/21/24 to 12/20/24 for Mastec North America Inc. work.
- Avista will be working at the following locations with flaggers on-site from 11/14/24 to 12/23/24.
 - The eastbound curb lane of US 2 will be closed between Campus and Spotted Road.
 - The westbound curb lane of US 2 will be closed between Russell and Spotted Road.
 - The northbound shoulder of Spotted Road will be closed between Tech Park Drive and US 2.
- Rowan Avenue between Hemlock and A Street will have flaggers on-site from 6/3/24 to **12/23/24** for TDS Metrocom residential fiber work.
- TDS Metrocom will be working at the following locations from 9/23/24 to **12/25/24**.
 - Eastbound lane closure of Rowan Avenue between Lidgerwood and Standard Street.
 - Eastbound lane closure of Rowan Avenue between Nevada and Magnolia Street.

- The northbound curb lane of Nevada Street will be closed between Beacon Avenue and Cozza Drive on 11/26/24 and 11/27/24 for new approach installation by Alpine Contractors Group.
- The westbound curb lane of Pacific Park Drive will be closed with flaggers between Parkway Drive to Lucia Court from 11/30/24 to 12/28/24 to support underground utility work by Mastec North America.
- The southbound curb lane of Browne/McLellan Street between 5th and 8th Avenue from 12/16/24 to 12/30/24 for Avista Utilities work.
- The two east curb lanes of Ruby Place between North Foothills Drive and Cleveland Avenue from 12/16/24 to 12/30/24 for light pole replacement by Avista Utilities.
- North Sky Communications will be working at the following locations from 12/16/24 to 12/30/24.
 - The southbound curb lane of Southeast Boulevard will be closed between 27th and 29th Avenue.
 - The westbound curb lane of 29th Avenue will be closed between Mt. Vernon and Lee Street.
- Mastec North America will be working in the following areas from 12/2/24 to 12/31/24 to support aerial fiber work.
 - The northbound curb lane of Regal Street will be closed between 30th and 29th Avenue.
 - Both curb lanes of 29th Avenue are closed with flaggers between Regal and Mt Vernon Street.
 - The eastbound curb lane of 27th Avenue closed between Mt Vernon Street and Southeast Boulevard.
- North Sky Communications will be performing utility work in the following areas from 12/16/24 to 1/3/25.
 - The northbound curb lane of Bernard Street will be closed between 32nd and 31st Avenue with flaggers on-site.
 - The westbound curb lane of 31st Avenue will be closed between Lamonte Street and Manito Boulevard with flaggers on-site.
- The southbound curb lane of Sherman Street will be closed between 3rd and 5th Avenue from 12/6/24 to 1/6/25 to support fiber work by Mastec North America.
- Crestline Street will be reduced to one lane between Rowan and Joseph Avenue from 11/25/24 to 1/6/24 to support aerial utility work by TDS Metrocom.
- Monroe Street will have southbound lane closures between Montgomery Avenue and Northwest Boulevard from 7/30/24 to 1/6/25 for TDS Metrocom work.

- TDS Metrocom LLC will be working at the following locations from 12/9/24 to 1/10/25.
 - Standard Street will have lane closures between Gettysburg Drive and Weile Avenue.
 - Cozza Drive will have lane closures between Calkins Drive and Dakota Street.
- Fatbeam LLC will be working at the following locations from 12/11/24 to 1/10/25.
 - Lane shift on Market Street between Rowan Avenue and Haven Place with flaggers on-site.
 - Lane shift on Market Place between Columbia and Nebraska Avenue with flaggers on-site.
 - Crestline Street between Nebraska and Central Avenue will have lane closures with flaggers on-site.
- The northbound lane of Assembly Street will be closed between Sanson and Olympic Avenue from 12/12/24 to 1/12/25 for Mastec North America work.
- Northsky will install fiber at the following locations from 12/26/24 to 1/14/25.
 - North Foothills Drive will have eastbound and westbound curb lane closures between Cincinnati and Perry Street with flaggers at the side street intersections.
 - Nevada/Hamilton Street will be reduced to one lane in each direction between Euclid and Marietta Avenue.
- Francis Avenue will have eastbound and westbound curb lane closures between Pittsburg and Nevada Street from 11/15/24 to 1/15/24 for Mastec North America Inc. work.
- Matec North America will work in the following areas from 12/16/24 to 1/16/25 for aerial fiber work.
 - Browne Street between 4th and 7th Avenue will have lane closures with flaggers on-site.
 - 5th Avenue between Washington and Division Street will have lane closures with flaggers on-site.
- The westbound curb lane of Francis Avenue will be closed between Howard and Wall Street from 12/19/24 to 1/19/25 for fiber installation.
- Assembly Street will have northbound and southbound lane closures between Olympic Avenue and Gustavus Street from 12/26/24 to 1/26/24 for fiber work by Mastec North America work.
- Magnesium Road will be reduced to one lane between Standard and Nevada Street with flaggers on-site from 12/27/24 to 1/27/25 for Mastec North America work.

SPOKANE PARKS AND RECREATION

COEUR D'ALENE PARK

- A new irrigation system is being installed February – spring 2024. The park will remain open for use, with rotating sectional closures.

STREET DEPARTMENT PROJECTS

LEAF PICKUP

- Leaf pickup is underway! The City's leaf pickup service is intended to remove only the leaves that naturally fall into the streets. **Residents *should not* rake leaves into the street.**

POTHOLE CREWS

- City crews continue to fill potholes as weather allows. If you see a pothole, report it by calling **3-1-1**. Potholes can also be reported online through [your MySpokane account](#). Crews focus on the largest holes on the busiest streets first. Include as much information as possible on the location and size of the pothole.

SNOW REMOVAL

- Residents are asked to park on the odd side of the street in residential areas for snow season, which runs from Nov. 15 to March 15.

WASHINGTON STATE DEPARTMENT OF TRANSPORTATION (WSDOT)

CHILDREN OF THE SUN TRAIL

- The Garland Bridge reopened as of Friday, Oct. 15. Minor work remains on the trail.

NORTH SPOKANE CORRIDOR-US 395/NSC SPOKANE RIVER CROSSING

- Riverton Avenue between Ermina Avenue and Fiske Street is closed.
- The Spokane River is closed at the Greene Street Bridge.

This project will construct the North Spokane Corridor bridge that will cross the Spokane River and connect the skyway portion near Spokane Community College to the south and at Carslie Avenue to the north of the river.
